

CONCEPT NOTE

On the occasion of International Women's Day 2021, the "Marianna V. Vardinoyannis Foundation" undertakes the initiative for an in-depth discussion on the major challenges women are facing in the era of the pandemic.

While lockdowns, social distancing and stayat-home orders may be crucial in limiting and preventing the spread of COVID-19, they also have a devastating impact on women and girls lives.
